Chairman Orlowski, called the meeting of the Suffolk County Farmland Committee to order at 6:05 p.m. at the L.I. Horticulture Research & Extension Center, Riverhead, NY.

## **Approval of Minutes**

A motion was put forth by Charles Scheer and seconded by Mark Zaweski to approve the minutes of the January 25, 2005 meeting of the Farmland Committee. Motion carried. 14-0-0.

#### **Public Portion**

Chairman Orlowski opened the meeting for public comments. There being none, the Chairman moved to the next item on the agenda.

# ECCO Farm-Long Lane, Marion Schnenk parcel, East Hampton

Lauren Jarrett, Director of ECCO Farms, made a presentation. ECCO Farm requested approval to move walk-in cooler 50 feet off the property line (previously built in the 50 ft. setback) in lieu of a future site plan approval for a barn, to enlarge farmstand structure to 300 sq. ft. semi-permanent seasonal structure, build a chicken coop and to change the location of several high tunnels. A motion for a SEQRA determination Type II Action was made by Albert Kilb and seconded by Russell Barnett. Motion carried. 14-0-0.

The Farmland Committee determined that high tunnels are considered farm equipment and did not come under the review of the Committee. Charles Scheer made a motion for approval of the walk-in cooler, chicken coop and future barn provided they submit a site plan for a precise location and meets town setback requirements. The motion was seconded by Elmer Zeh. Motion carried 14-0-0.

Ms. Jarrett also discussed arsenic testing and evaluation on ECCO Farm. Russell Barnett followed with a discussion on Smithtown's experience with arsenic standards.

#### Jeff Owen

Jeff Owen, the owner of Owen Brothers Nursery, asked the Farmland Committee's opinion on the construction and use of a Butler Building (60' x 100') for storage. He is selling his development rights to Suffolk County. Committee members felt that the Butler Building would be permitted as long as it was used as an agricultural structure and did not include any retailing activity. A suggestion was made that Mr. Owen return with a site plan for the July meeting.

Joe Gergela told the Committee that putting farms on lists without their permissions would be detrimental to the farmer. Chairman Orlowski stated that parcels would not be added to the list unless it that farmer submitted it himself. Janet Longo explained that after the approval a letter is sent out asking if the owner is interested. Tom Isles suggested that the Committee not adopt a firm stand at this time and that he would talk to his contacts in County Government. William Gardiner felt that the Committee should not approve any parcels that were not submitted by farmers.

#### **Other Business**

Janet Longo, Division of Real Estate, gave an update to the Committee. There are 285 acres in contract in 2005, 325 acres are accepted offers and 40 acres have already been closed on. She explained that the Appraisal Review Dept. and the Environmental Trust Review Bd. approved what amount can be offered. Licensed appraisers can review and now be competitive.

Joe Gergela stated that landowners can see the appraisals and has the right to get his own appraisal. Ms. Longo said Suffolk County would consider any legitimate comps.

The County is doing a seminar (May 5, 2005) for appraisers explaining the County's requirements for the appraisal process.

Mr. Gergela also informed the Committee that the "Quarter Percent Funding" might be switched from sewers to open space.
