Chairman Orłowski, called the meeting of the Suffolk County Farmland Committee to order at 6:05 p.m. at the L.I. Horticulture Research & Extension Center, Riverhead, NY.

Approval of Minutes

A motion was put forth by Charles Scheer and seconded by Albert Schmitt to approve the minutes of the April 26, 2005 meeting of the Farmland Committee. Motion carried. 12-0-0.

A moment of silence was observed for Jacob Rottkamp

Public Comments

Chairman Orłowski opened the meeting for public comments. There being none, the Chairman moved to the next item on the agenda.

White Post Farms

The boundary of White Post Farm has exceeded the property line and gone over into County property. Also, there were 16 greenhouses that he had not received approval for as well as concrete walkways which were never approved. Mr. Brigati also wants to legalize overnight storage of commercial vehicles as well as approval for outside storage of fertilizer. He is also maintaining a commercial composting operation which is not allowed. John Brigati of White Post Farms spoke. He informed the Committee that the property line has been corrected. He also agreed not to sell compost any longer.

Marija Gardiner, a nearby resident, spoke and complained about the odor from the composting.

Joe Gergela spoke to the Committee stating that this goes beyond farming operations and that he recommends contacting Ag & Markets to look at this and give a legal opinion.

A motion to contact Ag & Markets to make an inspection of the farm and its operation and report their findings to the Farmland Committee was made by Lee Foster and seconded by Nate Corwin. Motion carried. 12-0-0.

Chairman Orłowski told the Committee that White Post Farm will submit a site plan and that they will not sell compost.

Albert Kilb left the meeting due to a family emergency

Detmer Farm

The first part of a two-part request was from Norman Keil who asked for approval of a 6 ft. deer fence, wells, irrigation pumps and a loading dock. **A motion for approval was made by ----- and seconded by Elmer Zeh subject to a drainage plan, and to supply the Farmland Committee with a copy of the plan. Motion carried 11-0-0.**

The second part (owned by Daniel O'Neil) was regarding the inappropriate use of a farm store. The store seems to exceed the guidelines that County Law requires (80% must be grown on premises) and appears to be in violation of the items sold. There was also some question as to whether or not there was an inspection by the Health Dept. for cooking on premises and whether or

not they have an Ag and Markets permit. Jenny Kohn, Suffolk County counsel, suggested that an investigation be done to determine the irregularities and that for future reference a procedure to follow should be set up. **A motion was made by Chairman Orlowski to follow through with an inspection to determine if there are violations. This was seconded by Nate Corwin. Motion carried. 11-0-0.**

Woelffer Farm

Laura Brown, representing Woelffer, spoke to the Committee. They are requesting a barn renovation, a horse carousel, a fence and enlarging a pond for irrigation. The Committee requested that a site plan be supplied.

Roufanis/Fleming Farm

They are requesting permission to renovate the Fleming house and a barn within the footprint of the original building. The Farmland Committee will wait for a site plan.

Abbess Farm

Marie Tooker from Abbess spoke to the Farmland Committee. She requested a 100' X 200' metal training arena. **A motion for approval, subject to a site plan, was made by Elmer Zeh and seconded by Nate Corwin. Motion carried. 11-0-0.**

ECCO Farm

They are requesting to relocate an existing solar electric fence deer fence to fill in a gap along Long Lane. They are also asking permission to put in cattle guard entrances along either end. **A motion for approval was made by Lee Foster and seconded by Charles Scheer. Motion carried 11-0-0. A motion for a SEQRA determination Type II Action was made and seconded. Motion carried. 11-0-0.**

New Parcels

The following Southold parcels offered for the Suffolk County Purchase of Development Rights Program were approved, pending an acceptance letter from the farmer/landowner. ***A motion for approval was made by Charles Scheer and seconded by Joseph Krukowski. Motion carried. 11-0-0.***

Ellgreen (DeLea Sod Farm) - 26 Acres located in Huntington on Elwood Rd. scored 9 by the Committee. Joe Gergela told the Committee that the owner would use PDR money to buy more farmland. **A motion for approval was made by Charles Scheer and seconded by Russell Barnett. Motion carried. 11-0-0.**
